# Regular Agenda

Agenda Item 1. Lt. Mike Erhart provided the Sarpy County Sheriff's Department monthly report.

Mayor Dill commended Runza Restaurant and B&B Pit Stop for providing chili and pizza to the fire departments involved in the recent house fire.

Agenda Item 2. Connie Manzer, Library Director, presented the annual library report. Manzer reviewed the new building addition, library employees, recognitions received, and programs and services.

Nolte arrived at 7:11 p.m.

Agenda Item 3. Connie Manzer, Library Director, reported that the city library received a grand total of \$73,137.70 from the Viola Snider Estate. On behalf of the Library Board, Manzer requested that a new bank account be opened specifically for the estate proceeds. Motion by Roseland, seconded by Nolte, to transfer \$73,137.70 from the general checking account to a new savings account for the funds from the Viola Snider Estate. AYES: Roseland, Fleming, Craney, Nolte. NAYS: None. Motion carried.

Agenda Item 4. A Public Hearing of the Springfield City Council was opened at 7:15 p.m. to consider an application for a Class C Liquor License submitted by Garvey's Pub, Inc., d/b/a/ Garvey's Pub, 153 Main Street, Springfield. No one from the public spoke in opposition to or in favor of the application. Motion by Nolte, seconded by Roseland, to close the public hearing. AYES: Roseland, Fleming, Craney, Nolte. NAYS: None. Motion carried. Public Hearing closed at 7:16 p.m. Motion by Nolte, seconded by Roseland, to recommend approval of the application for a Class C liquor license submitted by Garvey's Pub, Inc., d/b/a Garvey's Pub, 153 Main Street, Springfield. AYES: Roseland, Fleming, Craney, Nolte. NAYS: None. Motion carried.

Agenda Item 5. Motion by Roseland, seconded by Craney, to authorize the operation of keno at Garvey's Pub located at 153 Main Street, Springfield. AYES: Roseland, Fleming, Craney, Nolte. NAYS: None. Motion carried.

Agenda Item 6. Brad Harris with Layne Western presented the Council with a bid for relining well #2 in City Park. Harris reviewed the construction timeline and procedures. Council Member Nolte introduced Resolution 2013-5 and moved its adoption. Council Member Craney seconded the foregoing motion and on roll call on the passage and adoption of said resolution, the following voted YEA: Roseland, Fleming, Craney, Nolte. The following voted NAY: None. Whereupon the Mayor declared said motion carried and said resolution passed and adopted. A true, correct and complete copy of said resolution is as follows:

# RESOLUTION 2013-5

BE IT RESOLVED by the Mayor and City Council of the City of Springfield, Nebraska as follows:

WHEREAS, the City of Springfield, Nebraska, a Municipal Corporation, and Layne Christensen Company, wish to enter into an agreement for professional services to reline well #2 in City Park; and

WHEREAS, the services provided by Layne Christensen Company shall consist of a full screen and casing liner to total well depth, including 50' x 8" SST screen, 9" steel casing, gravel pack, grout seal, development, chemical rehabilitation, and a new 6" Grundfos submersible pump and motor unit, complete with drop pipe, cable and other appurtenances; and

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of Springfield, Nebraska that the Mayor is authorized to sign the Quotation provided by Layne Christensen Company attached hereto as Exhibit "A".

Agenda Item 7. Fleming brought three existing folding chairs from the Community Building to the meeting for the Council to view. Fleming also purchased three different styles of new folding chairs that the city could purchase to replace the existing chairs being used for rentals. Council suggested that any new chairs be labeled on the bottom for city identification. Motion by Nolte, seconded by Craney, to purchase one-hundred (100) Lifetime white chairs from Sam's Club in the amount of \$19.98/each for use at the Community Building. Agenda Item 8. Council discussed Kent Maystrick's six-month review and considered a merit increase. Motion by Nolte, seconded by Roseland, to approve a 3% six-month merit increase for Kent Maystrick. AYES: Roseland, Fleming, Craney, Nolte. NAYS: None. Motion carried.

## **Department Reports**

Agenda Item 1. Roseland reviewed meeting notes from the new well project kickoff meeting he had with representatives of Olsson Associates, city water operator Rick Lee and Mayor Dill on January 22. Roseland provided a well location map and the Council discussed possible locations.

Agenda Item 2. Fleming provided informational packets from American Lift & Sign Service for proposed new electronic signs for the library and community building. Council considered sign options.

Agenda Item 3. No Department Report from Craney.

Introduced and Passed this 5<sup>th</sup> day of February, 2013.

Agenda Item 4. Nolte reported that the city maintenance department planned to repave the driveway entrance to the city maintenance shop located on Cedar Street in early spring. He said that the concrete would be extended into the city hall side yard for added parking spaces. Nolte also noted that a retaining wall would be constructed and the corner sign fixed up.

Agenda Item 5. Mayor Dill reported that the 911 regionalization study was still ongoing. He also reported that he and the City Clerk were working with the United Cities of Sarpy County on legislative bills. Mayor Dill informed the Council that he spoke with members of the community, who were instrumental in bringing the caboose to Buffalo Park, about the caboose being removed from the park.

Council agreed to have the city attorney begin the process for the city to remove the caboose from the park.
