Regular Agenda

Agenda Item 1. Lt. Steve Grabowski with the Sarpy County Sheriff's Department provided the monthly service report.

Agenda Item 2. Council reviewed the construction bids for the Main Street Phase 3 Project. Bids were received from Midwest DCM and Mackie Construction. The low bid was from Midwest DCM in the amount of \$104,989.25 with a substantial completion date of September 15 and final completion date of October 1. Denny Graham with Olsson Associates verified the bid quantities and checked references, all of which were good. Motion by Carlson, seconded by Craney, to approve the bid from Midwest DCM in the amount of \$104,989.25 for the Main Street Phase 3 Project. AYES: Carlson, Craney, Nolte. NAYS: None. Motion carried.

Agenda Item 3. Council Member Craney introduced Resolution 2015-4 and moved its adoption. Council Member Nolte seconded the foregoing motion and on roll call on the passage and adoption of said resolution, the following voted YEA: Carlson, Craney, Nolte. The following voted NAY: None. Whereupon the Mayor declared said motion carried and said resolution passed and adopted. A true, correct and complete copy of said resolution is as follows:

BE IT RESOLVED by the Mayor and City Council of the City of Springfield, Nebraska as follows:

WHEREAS, the City of Springfield, Nebraska, a Municipal Corporation, and Olsson Associates, wish to enter into an Agreement for Professional Services for services rendered on Main Street Phase 3 infrastructure improvements on the southeast corner of $2^{\rm nd}$ and Main Streets; and

WHEREAS, professional services provided by Olsson Associates shall consist of construction administration and observation services; and

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the City of Springfield, Nebraska that the Mayor is authorized to enter into the Agreement for Professional Services attached hereto as Exhibit "A".

Agenda Item 4. Rick Isenberg, owner of 360 Maple Street, requested that the city remove two dead trees on his property that are within the street right-of-way. Isenberg reported that on September 5, 2014, Terry Hughes looked at the trees and determined that they were both severely diseased and hazardous. City Attorney, Bill Seidler, referred the Council to Springfield Municipal Code §8-509 and noted that tree removal is the responsibility of the property owner. Motion by Carlson, seconded by Craney, to deny Rick Isenberg's request to remove two dead trees on his property at 360 Maple Street. AYES: Carlson, Craney, Nolte. NAYS: None. Motion carried.

Agenda Items 5-8. Council considered Ordinance Nos. 876-879 regarding trees. Motion by Nolte, seconded by Carlson, to table agenda items 5-8, regarding Ordinance Nos. 876-879, until the March 17, 2015, Council meeting. AYES: Carlson, Craney, Nolte. NAYS: None. Motion carried.

Agenda Item 9. Council reviewed current peddler regulations and considered changes to the municipal code regarding peddlers and street vendors. Council discussed the application of vending permits to community-wide events, insurance requirements, submittal of health license, submittal of sales tax license, and background checks on peddlers. Two Council Members will work with city staff to prepare an update to the municipal code.

Agenda Item 10. Council reviewed bids from NMC CAT and Bobcat of Omaha for the annual lease of a skid steer for the maintenance department. The city has leased a skid steer from CAT for the past five years. CAT quoted a lease of \$3,000/year, while Bobcat quoted a lease of \$2,700/year. Nolte reported that Bobcat has a large variety of equipment and attachments on site that can be rented as needed. The current city-owned attachments will work on either machine. Motion by Craney, seconded by Nolte, to approve the bid from Bobcat of Omaha in the amount of \$2,700/year for the annual lease of a skid steer. AYES: Carlson, Craney, Nolte. NAYS: None. Motion carried.

Agenda Item 11. Council reviewed a bid from Carlisle Roofing & Construction in the amount of \$45,709.00 for roof repairs at City Hall. Council requested additional bids and suggested the city consider roof alternatives. Motion by Carlson, seconded by Nolte, to table agenda item 11, regarding bids for roof repairs at City Hall, until the March 17, 2015, Council meeting. AYES: Carlson, Craney, Nolte. NAYS: None. Motion carried.

Agenda Item 12. Motion by Nolte, seconded by Craney, to approve a \$1.00/hour annual merit increase for Shirley Santee. AYES: Carlson, Craney, Nolte. NAYS: None. Motion carried.

Agenda Item 13. Motion by Nolte, seconded by Craney, to approve a \$.50/hour annual merit increase for Connie Manzer. AYES: Carlson, Craney, Nolte. NAYS: None. Motion carried.

Agenda Item 1. Roseland reported that Verizon continues to work on their new tower at Buffalo Park.

Agenda Item 2. Carlson reported that the maintenance department is continuing to make improvements at the Community Building. Improvements include updated flooring in the entryway and basement kitchen. Staff is looking into bathroom improvements as well. Carlson also reported that he attended the February library board meeting. Library staff is making revisions to the library strategic plan and re-categorizing books.

Agenda Item 3. Craney reported that the city needs to consider sewer study implementation.

Agenda Item 4. Nolte reported that he met with city staff and Kildow Construction to review the bid for the maintenance shop.

Agenda Item 5. No Department Report from Mayor Dill.

Agenda Item 6. The City Administrator reported that staff will purchase one additional spray feature for the splash pad with keno community betterment proceeds, as the Council budgeted.
