Regular Agenda

Agenda Item 1. Lt. Mike Erhart with the Sarpy County Sheriff's Department provided the monthly service report.

Agenda Item 2. Denny Graham, Olsson Associates, reviewed the construction bids for the Spruce Street Paving Project. Bids were received from Mackie Construction and M.E. Collins Contracting. The low bid was from Mackie in the amount of \$102,957.42 with a substantial completion date of July 30 and final completion date of August 30. Graham said that he verified the bid quantities and checked Mackie's references, all of which were good. He reviewed the water and storm sewer portions of the project and noted that costs associated with those items would not be included in the paving assessments. Motion by Roseland, seconded by Craney, to approve the bid from Mackie Construction in the amount of \$102,957.42 for the Spruce Street Paving Project. AYES: Roseland, Fleming, Craney. NAYS: None. Motion carried.

Agenda Item 3. Mark Mascarello, property owner of 174 Main Street, and his attorney, John Wieland, were in attendance to show cause as to why the condition of said property should not be found to be a public nuisance. Wieland informed the Council that Mascarello has installed blinds in the front windows and door, removed the junk from the backyard, and obtained bids for brick work and roof repairs. Wieland said that the roof cannot be repaired until the brick work is completed, which cannot be done until it has been above freezing for one week. He noted that the brick and roof repairs are approximately

two months out. Nolte expressed concern that the holes in the roof could affect the adjacent property owners. Mascarello said that he would temporarily cover up the holes to try to defend against rain coming into the building. Motion by Craney, seconded by Fleming, to table agenda item 3, regarding the public nuisance at 174 Main Street, until the May 20, 2014, Council meeting, during which time the Council will consider whether or not the nuisance abatement requirements have been met. AYES: Roseland, Fleming, Craney. NAYS: None. Motion carried.

Agenda Item 4. Don Dalton and Tom Webster, Jr. requested financial assistance towards Buffalo Park baseball field improvements, which include the purchase of bulk diamond pro conditioner for the field, mound and home plate clay, a concrete pad for the bulk product, a safety fence for the bullpen by the dugouts, and a poured slab for the batting cage area. Dalton also requested financial assistance for labor associated with the improvements. Council suggested that some of the labor could be done by the city's maintenance department and requested that Dalton and Webster work with city staff to determine what improvements can be done by city staff and report back at the March 18 Council meeting. Dalton and the City Clerk reported that Springfield Platteview High School would contribute one-half of the cost of the improvements as per their interlocal agreement with the city. Motion by Roseland, seconded by Fleming to approve the purchase of the bulk diamond pro conditioner, mound/home plate clay, concrete pad for the bulk product, safety fence for the bullpen, and concrete slab for the batting cage area in the amount of \$2,472.50, and to table consideration of contributing towards the cost of the labor until the March 18, 2014, Council meeting. AYES: Roseland, Fleming, Craney. NAYS: None. Motion carried.

Agenda Item 5. Roseland reported that city employees have requested that the Council consider increasing the number of hours of compensatory time that can be accumulated by an employee. Currently, employees can accrue 24 hours of comp time at any given time. Roseland suggested increasing the hours to 60-80 hours. Nolte suggested increasing the comp time to 40 hours. Craney said he did not want to increase the time at all. Rick Lee, Kent Maystrick, Heath Shemek, and Kathleen Gottsch, city employees, were in attendance to discuss this item. Council Member Roseland introduced Resolution 2014-9 and moved its adoption. Council Member Fleming seconded the foregoing motion and on roll call on the passage and adoption of said resolution, the following voted YEA: Roseland, Fleming. The following voted NAY: Craney. Whereupon the Acting Mayor declared said motion carried and said resolution passed and adopted. A true, correct and complete copy of said resolution is as follows:

RESOLUTION 2014-9

BE IT RESOLVED by the Mayor and City Council of the City of Springfield, Nebraska as follows:

WHEREAS, the City of Springfield reserves the right to establish and update personnel policies and procedures which are within their legal authority; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Springfield, Sarpy County, Nebraska, that the City of Springfield Employee Handbook Section 523 entitled "Compensatory Time" shall be amended to read as follows:

COMPENSATORY TIME

Compensatory time is a program that allows employees to accrue time off in lieu of being paid for overtime work. It is subject to all of the rules for overtime.

Employees will not be allowed to accrue more than 24 40 hours of compensatory time at any given time.

Upon termination of employment, employees will be paid for unused compensatory time that has been earned through the last day of work.

NOW, THEREFORE, BE IT FURTHER RESOLVED by the Mayor and the City Council of the City of Springfield, Sarpy County, Nebraska, that the City of Springfield Employee Handbook Section 523 entitled "Compensatory Time" shall take effect immediately.

Agenda Item 6. Candy Connery reported that she has organized a summer children's community theater program for the past ten years. She said the group consists of local children, grades 5-8. Connery noted that the group practices at a local church, but would like to perform the play at the Community Building. She requested that the city consider renting a sound system for the performance, as well as for two days of practice at the building. Connery obtained a bid from Midwest Sound and Lighting in the amount of \$600 for a three day rental with labor to set/deliver/strike. She said that approximately 200 people attended the play last year. She does not charge an admission fee or a fee for the children to participate. She does it strictly on a voluntary basis. Council requested that staff check into insurance requirements. Motion by Roseland, seconded by Craney, to table agenda item 6, regarding the rental of sound equipment for a children's community play, until the March 18, 2014, Council meeting. AYES: Roseland, Fleming, Craney. NAYS: None. Motion carried.

Agenda Item 7. Council considered disposing of the caboose at Buffalo Park. Tess Sykes with the Sarpy County Museum was present and expressed the organization's interest in obtaining the caboose for display at the museum. Sykes noted that the museum has the oldest standing train depot in Nebraska, which was built in 1869. She confirmed that funding is available and that the Museum Director and Board have agreed to move forward with this item. The City Clerk reported that the community group from Hendersen, Nebraska is still interested in the caboose and is trying to firm up cost estimates to move the caboose. Council agreed that it would be nice to keep the caboose in Sarpy County. Conditions of sale were reviewed and Council requested the appropriate paperwork be drafted to dispose of the caboose. Motion by Craney, seconded by Fleming, to table agenda item 7, regarding Resolution 2014-8 sale of the

caboose, until the March 18, 2014, Council meeting. AYES: Roseland, Fleming, Craney. NAYS: None. Motion carried.

Agenda Item 8. Fleming reported that the supports on a pipe at the wastewater treatment facility need to be repaired. He said that the work might require a professional opinion and work. Motion by Roseland, seconded by Fleming, to direct the city maintenance department to inspect the sewer plant pipe supports and obtain professional bids as needed. AYES: Roseland, Fleming, Craney. NAYS: None. Motion carried.

Agenda Items 9 and 10. Motion by Roseland, seconded by Fleming, to move agenda items 9 and 10 into executive session. AYES: Roseland, Fleming, Craney. NAYS: None. Motion carried.

Department Reports

Agenda Item 1. Roseland reported that there is an update on the Springfield Trail Phase 3 project. The City Clerk reported that the right-of-way portion of the project is complete and has been approved by the NDOR. She noted that bid letting is scheduled for May 2014. She said that in order for construction to begin this summer, all of the trees along the trail path need be removed by April 1 due to bird nesting requirements. Council agreed to proceed with the tree removal.

Agenda Item 2. Fleming reported that the library has begun working on their strategic plan. He also provided a status update for Springfield Days.

Agenda Item 3. No Department Report from Craney.

Agenda Item 4. No Department Report from Nolte.

Agenda Item 5. No Department Report from Mayor Dill.

Agenda Item 6. No additional city staff reports.

Jack Dover, 480 Elm Street, expressed concern with visibility at the intersection of 2nd and Main Streets, due to large vehicles parking in the top parking stalls along Main Street. He said it is very difficult to see traffic traveling along Main Street when a vehicle is stopped on 2nd Street attempting to cross or turn onto Main Street. He asked if the city could eliminate parking in the corner stalls along Main Street or make them ADA or compact car parking only stalls. Craney noted that the city considered ADA stalls during project design but could not put them there due to ADA requirements with loading and grade. Nolte said that he would check into this matter further and get back with Mr. Dover.

Motion by Craney, seconded by Roseland, to approve a \$.50/hour merit increase for Connie Manzer. AYES: Roseland, Fleming, Craney. NAYS: None. Motion carried.

Motion by Craney, seconded by Fleming, to approve a 3% merit increase, up to the cap amount, for Kathleen Gottsch. AYES: Roseland, Fleming, Craney. NAYS: None. Motion carried.
