Regular Agenda

Nolte arrived at 7:01 p.m.

Agenda Item 1. Lt. Topil with the Sarpy County Sheriff's Department provided the monthly service report. He reported that officers are monitoring speeding concerns on Main Street. He reported that a traffic light is planned for the intersection of Hwy 50 and Capehart Road due to Facebook construction. He noted that the department received a DUI grant.

Agenda Item 2. Andrea Mahoney, 185 South 3rd Street, requested permission to block off Locust Street from South 3rd Street east to the middle of the block for a birthday party on Saturday, October 7 from 12:00 p.m. to 5:00 p.m. Council noted that emergency personnel must still have access down the road if necessary. Mahoney noted that they planned to have a bounce house at the party. The City Administrator and Council directed Mahoney to keep the bounce house on private property because it is not allowed to be on the street. Mahoney agreed that it would be in the neighbor's yard. Motion by Nolte, seconded by Swenson, to grant the closure of Locust Street from South 3rd Street east to the middle of the block for a neighborhood block party on Saturday, October 7, 2017, from 12:00 p.m. until 5:00 p.m. AYES: Swenson, Herzog, Nolte, Craney. NAYS: None. Motion carried.

Agenda Item 3. City Administrator, Kathleen Gottsch, introduced the following exhibits to the Board:

Kirk Kobiela, property owner, reported that last Friday his doctor gave him permission to go to light duty. He is going to finish siding the back of the house, taking the siding all the way down the foundation. The trailer in the back will be hauled out soon. He acknowledged that the weeds need to be cut down again. He mentioned working on the retaining wall as well. Mayor Roseland asked Kobiela how much more time he needed to complete the work he identified. Kobiela said it depends on his cousin's work schedule and the weather, but it should be done before winter, hopefully by November. Motion by Nolte, seconded by Craney, to table agenda item 3, regarding nuisance abatement at 265 Main Street (Kirk Kobiela property owner), until the November 7, 2017, Council meeting. Agenda Item 5. Council discussed the layout and interior roadway at the new maintenance facility. The maintenance department will rock the internal roadway so residents can access the tree limb and compost piles during inclement weather conditions.

Agenda Item 1. Swenson reported that the sewer department purchased a new centrifuge for daily sewer sampling.

Agenda Item 2. Craney reported that he is obtaining bids for tuck pointing work to be done at the Community Building. Herzog reported that the library started their after school programs.

Agenda Item 3. Nolte said that the street department will soon be wrapping up for the season.

Agenda Item 4. Craney reported that the Buffalo Park walking trail project is in progress and the seating area at the ball field will begin soon. Note explained the different process now being used on the walking trail project. He said that the entire trail should have approximately a 3 ½ inch overlay.

Agenda Item 5. Mayor Roseland reported that he attended a United Cities meeting and will be attending the MAPA annual dinner along with Herzog. Roseland noted that he will be attending future sewer meetings.

Agenda Item 6. City Administrator, Kathleen Gottsch, provided an update to the sewer siphon erosion repair project.
