A regular meeting of the Mayor and Council of the City of Springfield, Nebraska was held at 7:00 o'clock p.m. at City Hall on September 20, 2016. Present were Mayor Bob Roseland; Council Members: Roy Swenson, Dan Craney, Chad Nolte. Absent: None. Notice of this meeting was given in advance by posting in three public places, one of the designated methods of giving notice. Notice of this meeting was given in advance to the Mayor and all Council Members and a copy of their receipt of notice is attached to these Minutes. Availability of the agenda was communicated in the advance notice and in the notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public. Agenda Item 2. Kim Schulte, 5016 NW Radial Hwy, Omaha, requested the Council waive the Community Building fee for an October 30 fundraiser event to benefit her uncle who is battling Stage IV colon cancer. Schulte said proceeds will help the family pay for medical bills. A silent auction, raffle, costume contest, music and spaghetti feed are planned for the event. No alcohol will be served. The event will last from 12:00 noon until 4:00 p.m. Council considered her request. No action was taken.

Agenda Item 3. The Springfield Board of Health reported to the Council that the nuisances at 485 South 2nd Street, legally described as Lots 5 and 6, Block 24, Spearman's First Addition to the City of Springfield, Sarpy County, Nebraska, have not been abated. The Board noted that on July 11, 2016, they determined the property to be a public nuisance as per Springfield Municipal Code §4-301 (3)(6)(7)(8)(9) and subsequently notified the property owner of the property of such determination and directed him to remedy the nuisances immediately. On September 12, 2016, the Board of Health met and determined that the nuisances at 485 South 2nd Street were not abated.

The City Administrator reported that Carlisle Roofing has completed repairs on the roof in the past. She noted that staff selected weathered wood as the shingle color.
